## What is an Electrician?

### Our Program:

The Western Oklahoma Electrical JATC (WDEJATC) is a joint Labor-Management training program and is a collaborative effort of the IBEW Local 1141 and the Oklahoma Chapter of the National Electrical Contractors Association.

In 1945, the IBEW and NECA established the National Joint Apprenticeship Training Committee (NJATC) by developing standards that are used nationwide to train thousands of men and women for demanding and rewarding careers in the electrical industry.

Our electrical apprenticeship programs offer an individual the opportunity to “Earn While You Learn”- where you are paid to learn and gain work experience under the supervision of a qualified journey person.

Our program is registered with the Office of Apprenticeship, U.S. Department of Labor, and the Veteran’s Administration. Veteran benefits will be available if an apprentice qualifies.

## Basic Qualifications for Entrance in Apprenticeship

A pool of eligible applicants shall be established consisting of individuals who qualify for an oral interview. To qualify for an oral interview, an applicant must meet the following basic requirements or have a minimum of 4,000 hours of substantiated electrical construction work experience for qualifications #4 to be waived. Military veterans who can document MOS training and a minimum of two years military experience applicable to the electrical construction trade may have qualifications #4 waived.

1. Must be at least 17 years of age to apply and 18 years of age to enter the program.
2. Must be a high school graduate, have a GED or a two-year Associates Degree. (You may make application if you are a senior in high school within 60 days of graduation.)
3. Minimum math—must have completed one full year of high school Algebra with a passing grade or one post high school Algebra course with a passing grade or successful completion of the ETA Online Tech Math Course:

4. Must have a qualifying score on an aptitude test as prescribed by the JATC Committee.
5. Must provide official transcript or transcripts from high school or post high school showing courses and grades and GED records if applicable.
6. Must possess a valid driver’s license (state ID’s not accepted.)
7. Must be willing and able to work full time on the job anywhere in our jurisdiction. (JATC can provide a list of counties in each jurisdiction.)
8. Applicants selected for the apprenticeship program will be subject to drug testing and/or physical examination.

*Alternate program available for those not meeting above qualifications.*
